

## ***Monograph Eight:*** ***Cosmic Warfare (2)*** ***Campaigns of Eradication***

**Behind the curtain of illusion that is physicality – a curtain deliberately pulled over our existence so that we cannot and do not see what is behind it – there is a profound Truth awaiting rediscovery. Human existence has been moulded and shaped by forces, by a *battle*, we are currently unable to comprehend, although this is beginning to change. An agenda of Darkness has robbed us of our rightful heritage – a beautiful Ancient Wisdom – and the consequences for us have been dire indeed.**

### **Looking Back Over History Through Different, Opened Eyes**

Just as humanity looks out at the Universe\* and sees only the physical universe thereby *seeing only one very small part of it out of context*, so, too, do we look at human history exactly the same way.

Have you ever seen those pictures that look like a random pattern of shapes and colours until you put on a pair of 3-d glasses? When you do, an entire hidden picture suddenly jumps out at you. When you look at anything, whether it be the cosmos or human history or even your own life, with and through eyes of *metaphysicality*, or higher dimensionality, whichever term you prefer, you see a vastly different picture emerge.

If we take history purely on face value, we see what we're familiar with, and historical events separated from us by centuries of time, or even millennia, are over and done with. They're in the past and have no real bearing on us today. Moreover, events separated from each other by the same time spans cannot possibly be connected. The idea, for example, that Caesar's campaign in Gaul is connected with the Albigensian Crusade over a millennia later, and both of these events are connected with the Nazis and World War II is ludicrous.

But if we look at history knowing higher-dimensional beings of Darkness\* have manipulated and shaped events, striking their dark bargains, using humans like pawns, always lurking in the shadows, unseen and unrecognised, then we begin to see a different picture emerge, and the idea of the interconnectedness of different events, regardless of the time between them, no longer seems so ridiculous.

Higher-dimensional beings, whether of the Darkness or the Light\*, exist outside of time, and they also know that events, actions, and choices shape human reality in *all* directions of time. Beings of Darkness can, therefore, shape and influence the human experience like a master chess player Working\* to a well-planned, well-honed agenda, always seeing many moves ahead, able to anticipate *any* move humans might make.

Furthermore, as higher-dimensional beings, they are possessed of a transcendent intelligence – a higher intelligence that is informed by higher-dimensional Knowledge.

Human intelligence cannot, therefore, compare, and nor can the human intellect in its current state comprehend much of what they are able to accomplish, nor how.

## **The Age-Old Battle Between the Light and the Darkness**

I have already said (in Monograph Seven) but will repeat here, across human history in its entirety, Light and Darkness, and all those who serve both, have been battling for control of human consciousness and, with it, human reality. Thus has human reality, human existence and the human experience been shaped by the battle between both sides. Moves, countermoves and countermeasures, attack and defence, agenda and strategy – a powerful, metaphysical tug of war with humanity caught in between.

But this battle is actually concentrated on, or fought over, something very specific. That is, in the analogy of the tug of war, the rope is vitally important, symbolising, as it does, a beautiful Ancient Wisdom – the Wisdom of the Guardians of Light – at one end and, at the other, the chronic, abject ignorance the Darkness needs to survive and thrive, and to control and manipulate human consciousness.

When the Light gains the ascendancy, the Ancient Wisdom governs human existence, as it was always meant to, and when it does, human culture thrives in every way – creatively, economically, psychologically, spiritually. More importantly, all souls incarnate in such a culture are protected from themselves, or, specifically, from the egoic identity of the incarnation. Thus, the Wisdom governing such a culture acts as the guardian of choice, intent, motive, and action.

When, on the other hand, the Darkness gains the ascendancy, chronic, abject ignorance characterises that society. In an ignorant culture and society, the human ego controls individual consciousness, and fear reigns supreme. Humans pursue their egoic wants, often ruthlessly, and they act out of, and often lash out in, fear. Consequently, the culture becomes hellish, certainly brutal. *Wounded psychology is insanity*, to varying degrees.

Worse, though, is the fact that, in an ignorant society and culture, the real damage occurs to and in the soul – the higher-dimensional consciousness. It becomes lacerated and bound up in karmic obligation and imbalance, and humans become trapped in this dimension of materiality, wholly unable to break free.

## **Keeping Souls Trapped in the Human Experience**

The brutality of ignorant choices and actions, the consequent laceration of souls, and the karmic bonding and imbalance that occurs when individuals hurt and harm each other, directly serves the agenda of the Si'il – the Dark Priests. They have a vested interest in keeping human souls trapped here, forcing souls back time and time again, incarnation after incarnation, because they need us to create human reality *and*, perhaps more importantly, they feed off our negative energy. They cannot create reality here by themselves. They can only create reality here through humans.

Furthermore, they also have a vested interest in keeping wounded psychologies intact, unresolved, unhealed, because the resulting insanity perpetuates the egoic hold and causes individuals not just to *remain* karmically imbalanced, but to add to it, to *exacerbate* it.

Plus, it is from our wounded psychologies that our negative energy comes, particularly in the form of negative emotions. And, conveniently for the Darkness, unresolved wounded psychologies are handed down to the next generation – a perpetuated legacy of fear (the movie *August: Osage County*<sup>4</sup> is a gruelling but perfect illustration of this).

So, while they themselves cannot exist in a culture that is governed by the Ancient Wisdom, courtesy of the fact that it protects and even facilitates the projection and expression of Light in the human soul, nor can they manipulate such a culture to become one of entrapment. They cannot get a foothold in a culture of Light. It is, therefore, vital, essential to the Dark agenda to obliterate the Ancient Wisdom.

### **Terraforming Consciousness**

To this end, the Dark Priests have Worked\* hard to form human culture into one of abject ignorance, like terraforming a new planet so that it can support and sustain the reality and the way of being they need to generate. In our ignorance, we don't know about them. So how can we know what they're doing to us, how they're using us? We can't.

When powerful souls of Light come as Guardians or great Teachers, Thinkers, Mystics, and Philosophers to seed, re-seed, promulgate and tend the rivers of the Ancient Wisdom, to send it flowing through the human experience, to raise consciousness and redirect it, the Darkness acts quickly and ruthlessly to obliterate it.

### **Making a Deal with the Devil**

It is also worth reiterating the terrible fact that human reality has been so successfully hijacked by the Dark Priests that they don't have to come here themselves to further their agenda of Darkness. There are many incarnate humans willing to do their dirty Work for them. The Si'il, the Dark Priests, are, then, able to Work through incarnated people, like Adolf Hitler.

There are rituals of binding, rituals of the blackest magic, that allow for the surrender of body and mind, giving entities of Darkness control over both. It is a merger of consciousnesses that allows one's own consciousness to be infused with that of these dark entities. In return for what? Well, for whatever is wanted, usually wealth, control, status, and, most especially, as with Hitler, power.

Working with beings of Darkness consciously can tend to send a human mind insane, as Hitler demonstrated. But there are, tragically, many people willing to sell their souls, their bodies and their sanity for whatever it is they want. These people make the most horrible deals with the devil, and so they have, down through the ages.

These people then, like Hitler, become Si'il puppets, and it is these people who, also like Hitler, have led campaigns that have, ruthlessly and effectively eradicated whole cultures, groups of people, and individuals – anyone who, either wittingly or unwittingly, threatens their systems of control and manipulation.

And never more is a group or a culture the target of their campaigns than when those groups and cultures are connected to the Ancient Wisdom by an enlightened priesthood.

## **Campaigns of Eradication: the Druids**

We think of men like Julius Caesar as an all-conquering historical figure, a hero, but beyond that, we don't give him much thought. He doesn't seem real to us because he is a figure in our history text books, someone to be studied and, perhaps, admired. Likewise, Alexander the Great.

In truth, these men craved power at all and any cost. Indeed, Caesar actively wanted to emulate Alexander. Because of this, they were both willing to barter their souls for it. Human life was expendable to them, merely a resource at their disposal, or a means to an end, and not just the lives of those they conquered but also the lives of their own men.

Julius Caesar was a conqueror, yes, but he committed genocide, wiping out a race of people, just as Hitler tried to do. So why is Caesar a hero to us and Hitler a villain? Is it just because Hitler's tyranny is closer to us in time?

Caesar slaughtered millions of Gauls – man, woman, child – and he enslaved as many as he killed. If you look at Caesar's campaign in Gaul with and through opened eyes, you see the agenda that is, tragically, commonplace in the landscape of human history. There was something that was the greatest of threats to the Dark Priests and their systems of control in Gaul – something they had to eradicate at all costs: the Wisdom of the Druids.

Druidic lore and the Druid priesthood were, in fact, seeded and tended by the Light, and, therefore, it was essential to the Dark Priests that they eradicate the Druids anyway, but they also needed to eradicate the Druidic Wisdom in order to pave the way for one of their greatest weapons: the Roman Catholic Church, like clearing the land so they could lay the foundations for their edifice of Darkness.

### **A Powerful Piece of Darkness on the Chess Board**

Did Julius Caesar strike a terrible bargain – supreme power in return for the subjugation of Gaul – a culture that was underpinned and governed by a beautiful, ancient Wisdom – and the extermination of the Druids – the stalwarts and priests of that very same Wisdom? Yes, he did. It's how it works. It's how *they* work.

What humans don't realise is that the supreme intelligence Caesar possessed was not entirely his alone. Nor were the moves he made, the steps he took, his choices and actions, his alone. And I'm not just talking about what he did to eradicate Druidic Wisdom either, nor to make himself a dictator in Rome, morphing Rome from republic into empire, streamlining and concentrating control as a result.

He was also, for example, highly instrumental in setting time in stone, so to speak, thereby negating the truth of it being fluid and cyclical – something the Druids knew and understood very well. Caesar negated the natural movement of the constellations, too, so that we are, now, at odds within ourselves – nature's cycles verses inflexible, fabricated time. Time in the modern era is, quite literally, man made.

That he made a dark bargain is the reason he met such a violent end – something the Dark Priests don't tell individuals when they seal their deals. He was also physically ill at

the end of his life, another price he paid for his dark bargain.

### **The Wisdom is Not So Easy to Snuff Out**

Once Caesar was finished with Gaul, there remained a significant problem. The Druids still existed and thrived in Britannia. So, of course, he and his Romans could not leave Britain in peace. They had to conquer Britain, too, and so they did, subjugating the Druidic cultures there and driving the Druids back onto the island of Anglesey where the Romans slaughtered them.

And this from a people, although conquerors, who were usually tolerant of the different religions they encountered. Typically for the Romans, assimilating the local religious mythologies and practices into their own culture was part of their strategy as conquerors. Not so Druidic lore and Wisdom. The Romans pursued the Druids relentlessly until there was nothing left of the Druid religion, and they imposed their gods on the Britons.

But there was, even after this, still a very big problem. The Scots. Despite their walls, the Romans never stopped trying to conquer the Scots and the Picts. They never managed it, of course. And what was the true Purpose of those walls? What were the Romans really keeping out of their empire?

The Dark Priests could not allow even the last vestiges of the Druid priesthood to survive. Complete eradication. Nothing less was acceptable because the Wisdom has a decided tendency to take hold again and spread if not stamped out completely. They finally managed it through the auspices of their new church.

Ever is it so with the Wisdom of the Guardians. The Si'il cannot leave even a single small flame of it burning or a single small stream of it flowing.

### **Campaigns of Eradication: Alexandria**

At the beginning of the first millennia CE, the city of Alexandria had become a beacon of enlightenment, as its famous lighthouse symbolised. It was a cosmopolitan melting pot of wisdom from a myriad of different cultures: Greek philosophy, Mithraism, Persian Zoroastrianism, Gnosticism, Hermeticism, eastern philosophies, like that of the Sufis, and the religion of the temples of Ancient Egypt.

Alexandria's library was famous throughout the ancient world, and still is to this day, as were its fabulous temples and priesthoods. The cultural fabric of the city was like highly fertile soil within which thought and belief, and consciousness itself, nourished as they were by Knowledge, flourished, evolved, thrived. Thus did this cultural fabric pose the greatest of threats to the Si'il and their systems of control.

In fact, with the fusion of Gnosticism, Hermeticism and Philosophy, and the freedom inherent in the culture for these three to flourish, Alexandria was the brightest of beacons that nothing after it has ever rivalled again, even to this day.

So, the Dark Priests and their minions moved against the Wisdom in Alexandria, many times, but particularly early in the 3<sup>rd</sup> century CE, and then, again, late in the 4<sup>th</sup> century,

and, again, because the beacon of it had not been properly snuffed out, early in the 5<sup>th</sup> century<sup>1,2</sup>. At first, they attacked Alexandria through the auspices of the Roman Empire, but then, subsequently, they used the most powerful weapon in their arsenal, like the death star in George Lucas's *Star Wars*<sup>3</sup> – the Roman Catholic Church – to obliterate it, tragically, successfully.

Alexandria's fabulous and famous library was burned down, destroyed, as were many of the books and scrolls and parchments contained therein, and the priests and priestesses of Alexandria's ancient temples were literally torn to pieces by mobs incited to violence by the Roman Emperor, Caracalla<sup>2</sup>, and by the stalwart protagonists of the early Catholic Church, specifically, the bishops of Alexandria<sup>1</sup>. The attacks were targeted, ruthless, relentless and brutal. Alexandria was obviously not going to be allowed to survive as the beacon it was.

The Catholic Church was, however, not stupid enough to burn all the contents of the library or the temples, contrary to popular opinion. Many of the more valuable texts were saved and exist, even to this day, in the archives underneath the Vatican. Stolen, pilfered, effectively removed from the human experience, and definitely kept out of sight and out of reach where they cannot influence or affect human consciousness.

Those texts belong to humanity and they should be returned accordingly. Would the Roman Catholic Church dare to return them? Expose humans to the incredible power of the wisdom in those texts? Of course not. Not a chance. And if challenged, they'll simply deny the texts are there.

With the demise of Alexandria, Athens replaced it as a beacon of wisdom and enlightenment, albeit a weaker one and not nearly so accessibly central, for a while, but that, too, was taken care of when Justinian I shut Plato's famous Academy and decreed that any wisdom contrary to Catholic dogma was heresy, and heresy, like treason, was punishable by death<sup>1,2</sup>. Under this particular eastern Pope, holding beliefs other than the orthodox institutionalised version he presided over tended to be fatal.

### **Campaigns of Eradication: Manichaeism**

When a Guardian of Light, Mani, came in his True Form\* (see Monograph Seven for an explanation of 'True Form'), in the 3<sup>rd</sup> century CE to seed the Wisdom in the form of Manichaeism following the great schism in Christianity, again, the threat was acknowledged by the Dark Priests and neutralised in a systematic campaign of eradication, this one conducted by the then-institutionalised, powerfully-controlling Zoroastrian priesthood (Zoroastrianism did not start out as an institutionalised religion, seeded, as it was, by the Guardian Zoroaster centuries earlier).

Torture, imprisonment, execution were all employed to dispose of anyone who adhered to or practiced the Manichaean Wisdom. Mani himself suffered a torturous and brutal death at the hands of the Zoroastrian priesthood.

And, then, because Manichaeism wasn't completely snuffed out, Justinian I, emperor of the Eastern Roman Empire in the 6<sup>th</sup> century, the same individual who closed Plato's Academy, decreed heresy was justifiably punishable by death, paving the way for him to conduct a campaign of his own against surviving Manichaeism with mass burnings, not

just of Manichaeans themselves but also of anyone protecting and harbouring them<sup>1</sup>. He then followed this with the establishment of an official investigative agency, the *Quaestiones*, tasked specifically with hunting them, exposing them, and eradicating them, like vermin<sup>1</sup>.

Despite this campaign, Manichaeism was still not completely snuffed out. It survived, it endured, although it was forced underground, out of sight and, therefore, under the waterline of the collective consciousness. In fact, it survived right up to the 13<sup>th</sup> century<sup>5</sup>.

### **Campaigns of Eradication: Gnostic Christianity**

You can see exactly the same pattern in the extermination of the Gnostic Christians. Gnostic Christianity, in all its variant forms, is the True Christianity, the Christianity that grew from the seeding of the Ancient Wisdom by Yeheshua [Jesus]. It is Gnostic Christianity, not literal, or institutionalised, Christianity – the Christianity that survives today – that truly resonates with the message and teachings of this particular Guardian.

Roman persecution of the Gnostic Christians is well documented and well known. The Romans quite literally fed the Gnostics, the early Christians, to the lions in the arenas designed for the blood sports that entertained the masses. Courtesy of Roman persecution, thousands upon thousands of Gnostic Christians died brutally for their beliefs.

### **Campaigns of Eradication: the Crusades**

The genocides of the three Crusades in the Middle Ages, courtesy of that powerful Si'il weapon, the Catholic Church, were instigated to eradicate the beautiful, enlightened, civilised cultures of the Middle East because the Sufis, for example, were yet another threat to the Dark agenda that required a necessary eradication. But the powers of Darkness were well aware that Gnosticism and Manichaeism had survived there.

Ignorance was so rife in Europe in the Middle Ages that the majority of the population was illiterate, and not just among the peasant populations. In such a culture, what was preached from the pulpit was believed without question. So when the Church preached across Europe in condemnation of the 'Infidel' and called for a crusade against the stain of the Infidel, thousands answered the Church's call.

The crusaders were also provided another incentive just in case eradicating the Infidel wasn't enough. They were promised forgiveness of sins which meant avoidance of an eternal afterlife in hell. But how were they to know just by looking at someone whether that person was Jew, Christian or Infidel? They couldn't know, and nor did they bother asking first. The streets of Jerusalem, quite literally, ran with the blood of the slaughtered, Jew, Christian, Muslim, Sufi, and others. And this not once but three times.

### **Campaigns of Eradication: Catharism**

An unwitting consequence of the Crusades, however, was the contact made by the rabble armies of the crusaders with surviving Gnosticism and Manichaeism (which is, in truth, a variant form of Gnosticism).

This was, you have to remember, at a time when Europe was languishing in the Dark Ages, so European consciousness was starving for Truth and thirsty for Wisdom. Brought back home by the crusaders, like a souvenir, or a virus (!), the Wisdom again gained a foothold, the result of which was the sprouting of Gnostic Christianity in Europe, particularly the Cathars in southern France.

### **When the Ancient Wisdom gets a Foothold**

Remember, when and where the Ancient Wisdom gets a foothold, the cultures practicing it thrive not just spiritually but economically, creatively, psychologically. Contrary to popular opinion, the Gauls, under Druidic guidance, were more advanced than the Romans in many ways. They used soap, for example, long before the Romans did.

Also, the Ancient Wisdom tends to be absorbed easily and very effectively by human consciousness, and it engenders absolute devotion, loyalty, and faithfulness. So, when it gets a foothold, not only does it stick, but it spreads like wildfire. You can see this with early Christianity itself which spread, despite persecutions and executions, like an out-of-control bushfire through the Roman Empire and beyond. And you can see it again with both Manichaeism in the Middle East and Catharism in Europe.

### **The Cathar Threat**

The religion of the Cathars threatened, early in the second millennia CE, to overrun Europe. The Dark Priests had to move fast to contain it, and so they did. Again, they harnessed their most powerful weapon. The Catholic army of cut-throats and mercenaries, armed with promises of rich rewards and the forgiveness of all sins, that marched against the Languedoc, the home of the Cathars, like the crusaders, did not stop to ask the people if they were Catholic or Cathar. They slaughtered whomever they encountered.

In Béziers, hundreds of men, women, and children took refuge in their Catholic church, no doubt mistakenly believing the Catholic army would respect the sanctity of a Catholic church. But the mercenary Catholic army barged into the church, still on their horses, and slaughtered everyone in the church. The estimate of dead in Béziers alone, once the mercenary army had finished there before moving on to the next town, is between 15,000 and 20,000<sup>1</sup>.

This, at the beginning of the crusade against the Cathars, set the scene, and the standard, for what was to come. The Albigensian Crusade, as the crusade against the Cathars is called, was a composite, over many years, of murders, mass burnings, torture, mutilation, brutality, psychological warfare.

And this is a Church supposedly paying homage to the god of Jesus Christ? Why can humans not see the polar opposites of the Light and its antithesis, the Darkness, and recognise which is which? The Ancient Wisdom gives people the freedom to explore and practice spirituality as they so choose, whilst the Darkness imposes its will, forcing its deceptive dogma down their throats, controlling, punishing, murdering anyone who believes anything contrary to that dogma.

And then, of course, the Albigensian Crusade spawned the famous Catholic Inquisition



whereby anyone who showed even the smallest hint by word or deed that they might not be Catholic was tortured and/or burnt at the stake. The Church developed tortures, like the rack, that saved them the bother of having to clean up spilled blood, and you could find yourself subject to that torture for the simple act of hanging your sheets out to dry on Sundays because this was a Jewish custom.

### **Campaigns of Eradication: The Catholic Inquisition**

The Inquisition was originally conceived of to complete the campaign of eradication, stamping out, finally and irrevocably, the last vestiges of Cathar heresy<sup>1</sup>, but it quickly snowballed into a means of eradicating other people who posed a threat, like women who could heal or who demonstrated even a semblance of other spiritual skills and talents – any woman, in other words, who exhibited the inherent characteristics of a priestess.

The Catholic Inquisition, like the Gestapo under the Nazis, was supremely ruthless, relentless, implacable, structured, organised, and invested with incredible power<sup>1</sup>. It is estimated that 5,000 Cathar *perfecti* (priests) were burnt at the stake in the century following the Albigensian Crusade<sup>1</sup>. The Si'il and those who serve them had learnt their lesson from the survival of Manichaeism. They were determined that the Cathar heresy would not survive, either above or below ground.

### **Campaigns of Eradication: the Jews**

That the Inquisition targeted other groups of people, too, namely, the Jews and women, says much about the threat of women and Jews to the Dark agenda. And, is it, then, just a coincidence that Hitler, a Si'il puppet, also targeted the Jews so ruthlessly, so relentlessly, so implacably?

Rome, too, under the generalship of Pompey, also conquered and committed genocide against the Jews, just as Caesar conquered the Gauls. Two of the most powerful men in our history, one looking to the east, the other looking to the west. So why, then, are the Jews such a threat to the Si'il Priests? Judaism, in its orthodoxy, is not of the Wisdom, so it is not for this that they are targeted (although, strong threads of the Wisdom in its Egyptian form are weaved into it, and are particularly manifest in Jewish mysticism).

Their DNA, which was seeded by the Light, is more able to hold the Light of Knowledge, and well do they of the Darkness know this. DNA has, in fact, been like the rope in our tug of war analogy – seeded, at different times, by the Light to raise consciousness, and tampered with, sliced and diced, by the Darkness to dumb down consciousness.

### **A Powerful Weapon of Eradication: the Roman Catholic Church**

In the modern era, humanity knows nothing at all about the real Christianity. So effectively has it been eradicated that humans believe the Christianity we have today is all there ever was. Not so. And nor is the Christianity we have today Yeheshua's [Jesus] true legacy.

But is it not becoming obvious just how valuable to the Dark Priests the Catholic Church has been as a tool of suppression, manipulation and control more generally, but,

specifically, as a tool for eradicating the Ancient Wisdom?

In the earlier centuries of its inception and existence, the Church hierarchy comprised many men exhibiting the characteristics of an incarnate Si'il (courtesy of their suppression of, and hatred for, women, the Si'il tend not to take on female incarnations). Abbot Anaud Amalric is a prime example. He was instrumental in raising the mercenary army that marched against the Cathars and the Languedoc. When asked by the mercenary soldiers how they were to distinguish Catholics from Cathars, the abbot replied, 'Kill them all. God will look after His own'<sup>1</sup>.

How is this, in any way, shape or form, to be considered godly behaviour? If God existed, would He really extol the virtues of genocide simply because it was carried out in His name? Or even turn a blind eye? What of His own commandment: thou shalt not kill? And, yet, it was upon men such as this abbot, and behaviours such as his that the Catholic Church is built. That the Church has blood on its hands is a gross understatement. It has as much blood on its hands as do the Nazis.

Cyril, Bishop of Alexandria is another prime example of an incarnation of Darkness. He incited the Christian mob to violence and persecution in Alexandria, ordering the murder of Alexandria's priests and priestesses<sup>1</sup>, one in particular, a woman, much-loved and brilliant, who was famously dragged into Cyril's church where she was torn limb from limb, her skin scraped from her body with oyster shells, and burnt.

Yet another is Justinian, Emperor of the Eastern Roman Empire, who instigated mass burnings of Manichaeans after his decree of heresy being punishable by death<sup>1</sup>, the same man who closed Plato's famous Academy in Athens, ending its seven- or eight-century life.

## **Blueprints of Eradication and Control**

All of the Dark strategies and methods of eradication, if successful, have become blueprints that are then employed at other times, in other places, and in other contexts. Why reinvent the wheel, after all? If it works, adopt it. You have to remember that we are talking about *one* group consciousness, comprising many individual ones in service to the Darkness, that exist outside of time. So, it is easy for them to develop blueprints that can then be implemented anywhere, at any time, and that can also be refined and honed to increase their effectiveness and efficiency.

So, for example, the strategy that underpinned the campaign of eradication of Manichaeism, developed under Justinian I in the 6<sup>th</sup> century, when he decreed heresy was punishable by death, followed this with mass executions, and then followed these with the establishment of the *Quaestiones* who were tasked specifically with hunting, exposing, and eradicating them<sup>1</sup>, was employed again in the form of the Catholic Inquisition in the 13<sup>th</sup> century, and, then again, in the form of the Nazi SS and Gestapo in the 1930s.

Technology had advanced by the time the Nazis employed this strategy so they didn't bother with the tiresome effort of burning the victims of their campaign of eradication at the stake, or on massive bonfires. They shot them and, as everyone knows, gassed them en masse in the gas chambers they built for exactly that purpose.

Likewise, the informer culture – one that causes family members to inform on each other, neighbour to inform on neighbour, friend to inform on friend, community member to inform on community member – established through the auspices of common laws and statutes following the crusade against the Cathars<sup>1</sup>, whereby those harbouring or not informing on Cathars could forfeit their own lands or, worse, bring upon themselves the same punishment, was fostered, honed to perfection by the Inquisition and was then employed, once again, in Nazi Germany to hunt down and eradicate the Jews.

In 1215, the Catholic Church compelled Jews in Europe to wear a yellow circle sewed onto their clothing<sup>1</sup>. In 1229, it became mandatory for repented Cathars to wear two yellow crosses sewed onto their clothing, and this was reinforced with severe, even fatal, punishments<sup>1</sup>. The crosses were to be of exactly-prescribed dimensions, and they were to be replaced if torn, damaged or worn with age.

Over 700 years later, did we not see the same strategy employed by the Nazis against the Jews using yellow stars? And why yellow? Because it stands out and is easily perceived. Thus were yellow circles, yellow crosses and yellow stars worn like brands.

And never more so did they of the Darkness develop blueprints of control, specifically mind control in the form of mass-hypnotisation and -anaesthetisation, and thought control, than under the regime of the Nazis before and during World War II (see Monograph Ten for details).

The control of consciousness afforded the Darkness and its agenda by institutionalised religion has weakened. At the same time, human consciousness is, right now, experiencing perhaps the most significant paradigm shift in aeons of time, and this, in itself, is weakening their systems of control. You know the old saying: desperate times call for desperate measures . . . if you can call World War II a 'desperate measure'. In terms of the agenda of the Darkness, many, many birds were killed with that one powerful stone.

The truth is, they of the Darkness knew new measures of control would be desperately needed, not back then, in the 1930s, but now. Right now. In our time.
